- **Fisheries Report:**



There is a standard survey planned for this year. This will be part of the coordinated assessment work on the entire “Bemidji chain” which includes Bemidji, Stump, Irving, Marquette and Plantagenet. Regarding the stock rotation: There is nothing this year, then both walleyes and muskies will be stocked next year. Also, part of the survey work this year will be to assess the distribution and movement of walleyes stocked as fry into Plantagenet the past several years, as they were marked with oxytetracycline prior to stocking.

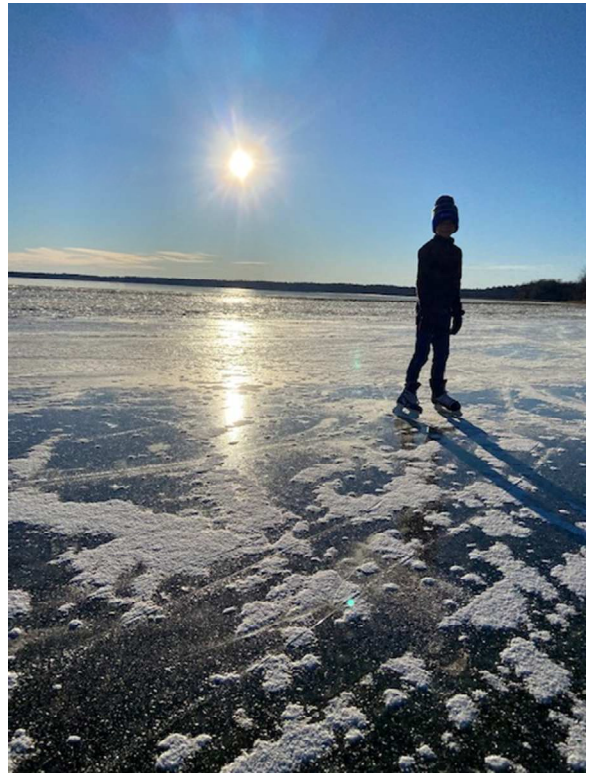

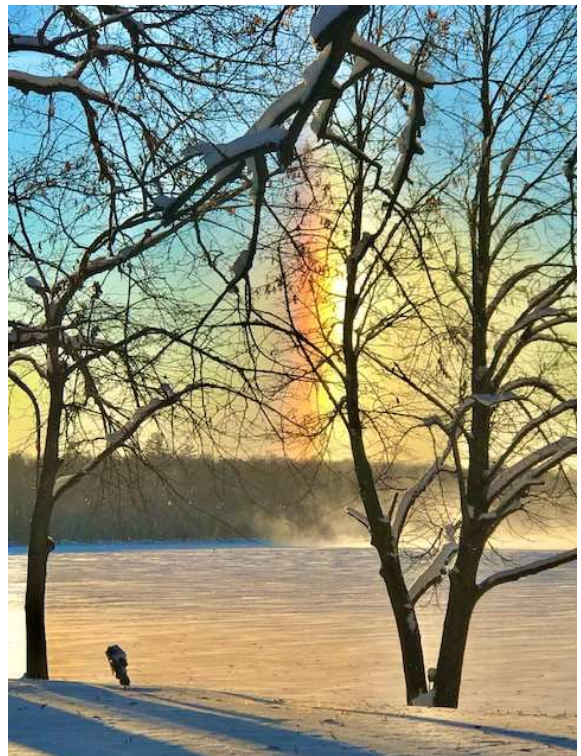
